Festivals and Events in Gunnersbury Park (change in the order of the published agenda)	Gunnersbury Park CIC	<ul style="list-style-type: none"> Gunnersbury Park CIC is a social enterprise that commenced in August 2017. Its remit is to raise finance to reinvest back into the park and its museum. Plans for Lovebox & Citadel festival in July, have been scrutinised in advance. The festival organisers are in direct contact with Ealing Council, Hounslow Council and emergency services as part of the Safety Advisory Group. The Secret Cinema is a smaller event to run over August. These events coincide with the development of the park's Sports Hub. However, the park will be returned after the Secret Cinema has closed. The park is a location for community oriented events and these are subsidised by the larger commercial events.
2.2)	The meeting asked several questions about the development of Gunnersbury Park and its events. Responses from David Bowler are noted.	Gunnersbury Park CIC	<ul style="list-style-type: none"> Operating times for the current controlled parking zone (CPZ) around the park will be replicated on event days. Letters will be distributed to affected properties. The Lawn Tennis Association funded the new tennis courts, which had to be built in advance of other developments in the park. The restoration of the Small Mansion building requires up to £4million of funding. The boarded-up house by Lionel Road and Popes Lane will be sold to cover a funding shortfall. Up to five events are expected in the park. Three venues in the park are seeking a wedding venue license. The temporary road through the park from Lionel Road, built by the building contractor will be removed at the end of development.

Parking pressure in CPZ D roads during its nine months of operation is increasing vehicle parking in Elderberry Road. A petition is to be raised to prevent commuter parking in Carberry Avenue. There is a knock-on effect to residential roads in Ealing Common ward from the decision to ban turns at Gunnersbury Lane at Uxbridge Road by Acton Town Centre. There has been no explanation to overrunning roadworks in Creffield Road. Residents should be notified with updates and explanations.

In conclusion, the council will not be removing the speed humps.
