Purpose of Report:

The final version of the **New Agreed Syllabus for Religious Education 2020-2025** ‘*Religion and Worldviews: Believing, Behaving and Belonging*’ has been developed by SACRE, supported by Religious Education professionals as well as the borough’s RE school networks and subject heads.

The report replaces the previous syllabus for Religious Education, ‘*Sowing the Seeds of the Future: An Exploration of Human Beliefs and Values*’, which was published in 2014.

The new syllabus seeks to build on the earlier provision in a number of distinctive, yet integrated, ways.

1. Recommendations

- 1.1 To consider the draft syllabus for religious education attached as Appendix 1
- 1,2 To recommend to the Council that the New Agreed Syllabus for Religious Education is adopted in substitution for the existing Syllabus

2. Reason for Decision and Options Considered

The locally agreed syllabus is a statutory syllabus of religious education adopted by the Local Authority. It must be followed in maintained schools without a designated denomination.

In addition to establishing a Standing Advisory Council on Religious Education (SACRE) Local Authorities are required to establish an occasional body called an Agreed Syllabus Conference (ASC) for the purpose of reconsidering the agreed syllabus.

5. Legal

Section 375 and Schedule 31 Education Act 1996 set out the statutory requirements with respect to the review and approval of the Agreed Syllabus. On any question to be decided by the ASC a single vote shall be given for each of the committees constituting the ASC.

S 149 Equality Act 2010 requires Local Authorities and schools to have due regard to the need to:

The proposal to review the Agreed Syllabus was agreed at the SACRE meeting in February 2019. Following extensive consultation with Ealing schools, SACRE received a report in June 2019 and a new syllabus was commissioned following a presentation from Reverend Andrew Williams from University of Roehampton. An initial draft was made available in October 2019 to SACRE members and schools for feedback and comments. Detailed feedback was received from four SACRE members.

In February 2020, a meeting was held with primary schools attended by Reverend Andrew Williams and in March RE subject leaders from high schools met to review the syllabus. Feedback from all groups was incorporated into the final version of the syllabus.

16. Timetable for Implementation

It is envisaged that the Agreed Syllabus will be agreed by the ASC and adopted by the Local Authority for full implementation at the start of the Autumn term 2020.
